- Voting is open to all projects with one vote per project, so please make sure to vote via the Web System “Committee Member Confidence Vote” (委員信任投票) within this period.

- We conduct questionnaires about this year’s May Festival for project managers.
- The result of the questionnaires will be used to make next year’s festival smooth and satisfactory for projects. We will be glad to hear your opinions.

Refunds

- **We will refund the deposits by bank transfer.** The transfer is scheduled to be made around **late June to early July.**
 - » The transfer will be made to the bank account registered in “[19]Registration of Bank Account”([19]返金用口座情報登録).
 - » After the transfer is completed, we will contact you via “Inquiry”. Please be sure to check that the money has been transferred correctly.
- For projects without any notable issues, the Committee will refund **the full amount.**
- Refunds will be given on the following dates for **projects that have requested in-person refunds in advance.** Please come at a date that is convenient for you within the following time.
 - June 21th (Fri.) 6:30 pm - 8:30 pm (Hongo Campus / Room 212, 1st Floor of Faculty of Engineering Bldg. 2)
 - June 25th (Tue.) 6:30 pm - 8:30 pm (Komaba Campus / Room 1212, 1st Floor of Bldg. 12)
 - » If you cannot come at the dates above, refunds will be given at the Committee Office (Second Cafeteria, 3rd Floor, Room 6). Details will be sent to you via “Inquiry”.
- Remaining ice tickets can be refunded. Please bring your ice tickets with you at your preferred time among the above, and the Committee will refund them. Refunds will be issued along with the Project Guarantee Deposit.
 - » If you cannot come at the dates above, you must come to the Committee Office in Hongo at other dates. Please contact us via “Inquiry” for an appointment. Ice tickets must be refunded by June 25th (Tue.), and we will not accept any later on.
- Any changes related to the additional rental or purchase of goods after the Payment Period will be refunded at the same time.

Financial Aid in Subsequent Festivals

- The financial aid system for projects may be abolished in the 98th May Festival.
 - » Due to the financial situation, it is likely that the Committee will not be able to secure enough budget to allocate for financial aid.
 - » The final decision will be announced in the Information Session for Participants (the 1st Information Session) of the 98th May Festival.
